

## NORTH YORKSHIRE COUNTY COUNCIL

The School Governance (Federations) (England) Regulations 2012  
(as amended by The School Governance (Constitution and Federations) (England)(Amendment) Regulations 2016)

### INSTRUMENT OF GOVERNMENT

1. The name of the federation is: The White Rose Federation.
2. The names and categories of the schools in the federation are:

Name	Category
Barlow Church of England Voluntary Controlled Primary School	Voluntary Controlled School
Burton Salmon Community Primary School	Community
Chapel Haddlesey Church of England Voluntary Controlled Primary School	Voluntary Controlled School

3. The name of the governing body is: **"The White Rose Federation"**
4. The governing body shall consist of the following (this depends on the number and categories of schools in the federation under Part 4 of the Federation Regulations):

Category of Governor	No of Governors in each category
Headteacher of the Federation	1
Parent governors	2
Local Authority Governor	1
Foundation Governors	2
Staff Governor	1
Co-opted governors	3

5. Total number of governors is ten (10). The Federation Governing Body will be able to invite additional associate members as required to meet the needs of the skills required on the governing body.
6. The term of office for governors shall be 4 years.
7. Foundation Governors are appointed by the York Diocesan Board of Education after consultation with the Parochial Church Councils of the Parishes in which the schools are situated.
8.
  - a. The holders of the following offices shall be foundation governors ex-officio: The Principal Officiating Ministers of the Parishes in which the schools are situated.
  - b. The Archdeacon of York shall be entitled to appoint a foundation governor to act in place of the ex-officio foundation governor whose governorship derives from the office named in a. above, in the event that the ex-officio foundation governor is unable or unwilling to act as a foundation governor, or where there is a vacancy in the office by virtue of which his or her governorship exists.

9. The Archdeacon of York is entitled to request the removal of any ex-officio foundation governor and to appoint a substitute governor.
10. Chapel Haddlesey Church of England Voluntary Controlled Primary School has a Trust Deed, namely, the Church of England Trust, dated 17 May 1875.
11. The ethos of Burton Salmon Primary School (BSPS), Barlow Church of Education Voluntary Controlled Primary School (Barlow) & Chapel Haddlesey Church of England Voluntary Controlled Primary School (Chapel Haddlesey) are as follows:

**BSPS**

- At Burton Salmon School we recognise that not only must we encourage our pupils to play an active and harmonious role within their own school community but must also prepare them for life in a wide and varied world.
- We work to support our pupils in developing an awareness of what is often referred to as 'British Values'. We also strive to ensure that our pupils know that these key values are shared by many people around the world and how we as individuals can adopt them in our lives.

**Barlow and Chapel Haddlesey**

- "Recognising its historic foundation, the school will preserve and develop its religious character in accordance with the principles of the Church of England and in partnership with the Church at parish and diocesan level.
- The school aims to serve its community by providing education of the highest quality within the context of Christian belief and practice. It encourages an understanding of the meaning and significance of faith, and promotes Christian values through the experience it offers all its pupils".

12. This instrument of governance comes into effect on the 12<sup>th</sup> of October 2020.

13. This instrument was made by order of North Yorkshire Local Authority on... 6<sup>th</sup> October 2020

14. A copy of the instrument must be supplied to every member of the governing body (and the Headteacher if not a governor), any trustees and to the appropriate religious body.
