Verbal reports -

- a. CBO reported that a heating firm was attempting to colour match their wall mounted infra-red heaters to the surrounding stonework. If that could be achieved it would enable more churches to install such heaters without adversely impacting on the building interior and that, coupled with switching to a green energy supplier, could help them to meet their net zero carbon target.
- b. **Beverley Saint Mary** at the site visit on 17th January the land to the north of the church was also discussed. The parish hoped to create a level access from the church hall into the church (through the door next to which the organ was sited at present) and also to connect the churchyard with the adjacent memorial garden (owned by Beverley Town Council). The boundary wall between those two parcels of land, on the east side of the church, appeared to be constructed of Flemish bricks but was in fact was a mixture of materials and appeared to be largely of Victorian date. The 'doorway' in the wall might have been a folly, or part of a building moved from elsewhere, but its significance (if any) was unclear. It could be retained if the remainder of the wall could be lowered. CBO had reminded the parish about their obligations regarding the pipe organ; Christ Church Dublin had expressed an interest in the pipe work but wanted to hear it pre-purchase and that would entail the parish spending a considerable sum to make those organ pipes playable.
- c. **Nether Poppleton Saint Everilda** the church was located beyond the furthest reach of the village's fibre optic cable and so satellite broadband was the only option. A site visit had clarified where the satellite dish could be positioned so as to have the least impact on the building. It would be coloured to match the roof slate.
- d. West Acklam Saint Mary they had sold their church hall and wished to re-order the church interior, removing the pews from the north aisle. CBO had suggested that they swap those pews with those in the current nave so that the decorative Victorian pews would be kept and the 1950s pews be disposed of. They also wished to make a disabled access into the Porch, which at present was entered from the west rather than straight on from the south; the Porch would be remodelled to provide an entrance on the south side to facilitate access and also provide a clear view into the body of the church. WC facilities would also be made more accessible than at present.

a. Chairs – CBO requested that a discussion be tabled for a future meeting to consider the DAC's position regarding the introduction of upholstered chairs into Grade II listed churches. The committee was aware that a more nuanced and pragmatic approach might be helpful to those churches where insufficient funds were available to purchase chairs of the quality usually required by the DAC and that inability to acquire appropriate seating was a stumbling block to missional and community activities. A decision tree might be helpful to ensure that the DAC's commitment to good quality seating was not compromised. The Secretary would also enquire of the DAC Officers' Google Group how other DACs were approaching this problem.

The Secretary explained that (1) the duty under Section 35 of the EJCCM 2018 had been extended to read: "A person carrying out functions of care and conservation under this Measure, or under any other enactment or any rule of law relating to churches, must have regard to (a) the role of a church as a local centre of worship and mission, and (b) the importance of environmental protection" and (2) that the DAC constitution would need to be amended because the requirement for one DAC member to be appointed after consulting local authorities was to be removed, a requirement for one DAC member to be appointed who has knowledge of environmental matters was to be added, and there would be a further requirement for the DAC to include at least one member with personal knowledge and experience of issues that need to be addressed when considering how to secure accessibility for disabled people to buildings and facilities. The steps required to comply with the constitutional changes need not, but may, be taken before the date when the next new appointments were due to be made (i.e. end 2027 for Jan 2028).

Both the church architect and the Committee had recommended that the new windows should include at least two ventilators, but the parish had pushed back hard against this on the grounds that no reason had been offered for the inclusion of ventilators, that in the last 40 years they had not known the existing ventilators to have been open, and

that they assumed ventilators were included in the 1884 restoration when the heating was by a solid fuel (probably coal) burner with a chimney going vertically through the roof; they would prefer not to have to pay for something that had no purpose. It was clear that the parish had not grasped the fact that ventilators were provided for the benefit of the building, not the people in it. As regards the new window quarries, the church architect had noted that a photograph of the church dated 1883 clearly showed rectangular quarries, and his suggestion of reverting to this original design had been welcomed by the parish. The glazier had confirmed that supplying rectangular quarries rather than diamond would reduce the overall costs. The Stained Glass Adviser had indicated to the Secretary that although rectangular quarries were actually less stable that diamond quarries, the case for changing back to rectangular was based on the earlier character and appearance of the windows in question and so she would not object. However, as regards the parish's suggestion that having the very top diamond shaped glass in sky blue stained glass would add to the attraction of the windows, neither the Stained Glass Adviser nor the Committee could see any good reason for such a change and if the parish sought to add it to this application then they would object to it. Having advised the parish that ventilators should be included, if the parish chose to exclude them then the Committee would not oppose this application for the lack of them. Subject to receipt of an amended quotation from the glazier this application could be recommended and moved forward between meetings.

The churchyard was full so there was a need to extend it into the adjacent field, previously reserved for this purpose by the Diocese. The existing graveyard, whilst not having gravestones throughout, had been a burial ground for over 1200 years and every interment found evidence of previous occupation. The unoccupied area at the west of the existing churchyard had rock close to the surface and was unsuitable for burials, as was the wooded north corner of the churchyard. The existing boundary wall, marked A-C on the plans, had collapsed in places; the stone from that collapsed wall would be re-used in the construction of the new boundary wall (plus additional stone from the Thornton Dale Estate). The planning application for this proposal had been approved by the NYMNP. The Committee agreed that the proposed new boundary would be aesthetically pleasing. The prime objective was to enable burials to continue at Ellerburn and this churchyard extension would allow burials for the foreseeable future. There was no mention of the inclusion of the Levisham Anglo Saxon stone fragments, but in any event that would require a separate faculty.

The Committee noted the tender report supplied on behalf of the parish. There appeared to be marked differences between the quotations referred to; it was agreed that the Secretary would request copies of the other lower quotations for comparison. Were the quotations supplied last year still valid? Could any economies be made? At least one contractor had not been able to tender — could they do so now? There was no PCC resolution to confirm the appointed contractors. Subject to that clarification this application could be recommended and moved forward between meetings.

The replacement emergency lights had been installed following recommendations of a Fire Safety inspection. The existing lights were no longer functioning and had proved impossible to repair due to their position on such a high ceiling. Ecclesiastical Insurance required the lights to be replaced because the church was hired out to other

organisations on a regular basis. Unfortunately, the parish had neither sought the DAC's advice nor their architect's advice, nor had they sought faculty permission beforehand, and most regrettably the twin spotlights had been affixed in a very prominent and visible location on the top of the very attractive narthex (designed by I Hayton, and installed only in 2019). K Halliday had visited the church recently and thought that the lights did not look as bad on site as they did in the photographs shown to the Committee. Nevertheless, it was agreed by members and advisers alike that there were a number of much better alternatives (including fixing lights to the side walls at lower level, fixing the lights behind the top of the narthex so that only the spotlights were above it etc) which would have been far less intrusive. Moreover, the position of the two lights was not optimal from an emergency lighting point of view. With lights fixed at the back of the church facing directly eastwards there was a risk of the lights shining into the faces of those trying to exit the building and dazzling them i.e. the last thing you would want in an emergency. Another good reason for fixing the lights to the side walls where they could shine diagonally across the path of people exiting the building. It was agreed that a Lighting Adviser (T Mitchell) should be asked to visit the church to advise the parish where the lights should be moved to so as to be effective (and that would also improve the aesthetics).

The South Porch pan tile roof had partially collapsed because the timber support structure had failed, so it was no longer secured to the main church structure. The proposal was to remove and reconstruct the roof and the top of the porch walls (which were brick built up on top of a rubble wall). As the drawing provided was confusing, the church architect confirmed that the build up would be felt, battens, tiles as usual. Another Advising Architect noted that the roof had a low pitch and would be susceptible to wind driven rain going underneath (which was probably why the structure failed originally). The church architect confirmed that failure was also likely to be due, in part, to the absence of any tie. A truss with a tie would be inserted to provide more stability and the architect would check whether sarking should be introduced underneath. K Halliday advised that this church was being added to the HAR.

The Sustainability Adviser and K Halliday both observed it was now generally accepted that the move to hydrogen was unlikely to be made and therefore "hydrogen ready" boilers would be of less benefit to the drive to net zero carbon than had previously been thought. The church was presently without heating; their boiler had broken down in 2022 and although spare parts were not available their heating engineer had managed to repair the boiler and keep it going for a while longer. Would electric radiant panel heaters be a better option? The church architect advised that the church had not long ago added an extension with new radiators and pipe work, so the parish would be unlikely to want to switch heating to an electrical supply after such an expense. It was a warm and well-used church. The parish had considered the net zero guidance. This petition could be progressed under the Delegated Authority Policy dated 6th October 2021 and would therefore be referred to a Heating Adviser for comment and recommendation. The Secretary would check whether the parish had completed their EFT.

Inside the building the parish wished to install WC and kitchenette facilities in the north west corner where there was already an old robing area curtained off, with no pews in it. However, the new WC cubicle would extend further east than the curtained area and it was unclear how many pews would need to be removed because this was not shown on plans supplied; the specification simply stated "move existing Pews to the area where the new WC is to be constructed".

The number of pews to be removed should be clarified. How would the existing window be treated? It appeared that some of it would be obscured by the new WC cubicle but the exact relationship between the two was not detailed. What was the design for the outside of the cubicle, the cladding etc? Outside, the east window of the Porch would be removed and replaced with a door to give level access into the building. Would the existing south door be locked or would both doors be in use at the same time? There was insufficient detail given of the new Porch door; the existing window had chamfered stone reveals, so the new doorway would need some details (more than just "stone Gothic arch lintel"). The eaves were not very tall – would there be sufficient headroom? Could the pathway and the ground level around the Porch be raised so as to provide level access? No, because there was insufficient run-up to the front door for an acceptable degree of slope. However, the path on the east side of the porch (if moved a bit further south) could be sloped up to a raised area around the south doors of the Porch to accommodate wheelchair access, leaving the window in place and using the south doors as access for everyone, and providing steps on the south side of the platform for those approaching the church along the footpath; that would save a lot of money.

The church organist had given a presentation to demonstrate to the PCC and congregation the current shortcomings of the organ and to give, from the congregation's perspective, an indication of how the proposed changes would be of benefit in services. The congregation were unanimous in their support of pursuing the scheme once the need had been demonstrated. These plans had been designed following the findings and recommendations of a drainage survey carried out by civil engineering contractors and a survey of the churchyard by archaeologists from the East Yorkshire Archaeological Society led by Dr Peter Halkon (Department of Archaeology, University of York). Dr Halkon would have archaeological oversight of the project. The work would be carried out by volunteers including a builder and a landscape contractor. The faculty petition noted that the church architect had been asked for general advice but no comments from her had been provided so the Secretary suggested that the architect should be approached to confirm that she had had sight of these proposals and was happy with them. The DAC's Archaeological Adviser, Prof H Mytum, agreed that the proposed works would definitely require an AWB; even if there had been previous disturbance, given that the works would affect stratigraphic links between the church building walls and the churchyard all round, as well as the soakaway, it warranted some observation. Even the exposure and some recording of the below-ground

foundations could be informative. A geophysical survey and test pits (permitted under a List B (AMO) application) confirmed that the drains and soakaway do not encroach on any graves. Prof Mytum thought it would have been interesting to see the geophysical survey results, as the use of geophysics in churchyards was notably problematic and he doubted that the survey results would have been particularly informative. More thought needed to be given as to how they would use the archaeology effectively to help them implement this scheme properly. An Advising Architect with previous experience of this church noted that it had always had problems with damp. He thought that the report from the drainage contractor seemed to make assumptions about where the drains ran i.e. that they ran away from the church to a mains drain, which he thought was probably incorrect - he suspected that they ran to a soakaway – so the archaeological aspect would be very important and some primary excavation might be needed to go out to the main road. Presumably consent to discharge would also be needed.

There was limited space in this church for fellowship, meetings, events and fundraising activities, so to create some usable space the Saxon Cross would be moved from the base of the Tower to the west end of the north aisle, four Victorian pews and their platform (installed during the 1873 restoration) being removed to make way and a new stone floor being laid to support the cross. The Nunburnholme cross was regarded as one of the most important items of its kind in northern England and probably dated from the 10th century. It needed repair because during a previous attempt at restoration its two halves had been misaligned by 180 degrees and fixed together with Portland Cement. It was also very likely that the two halves of the cross had been secured with metal rods which were now rusting and which might eventually lead to cracking of the cross; any such rods would need to be replaced with a suitable modern alternative i.e. stainless steel or carbon fibre. The Cross would be positioned in its new space in such a way as to allow 360 degree accessibility and spot lighting would be installed to ensure it was appropriately lit. The 13th century stone font would be moved closer to the door to create a better, wider access to the base of the Tower and to make the font more accessible. The scheme had the support of the church architect. Much of it was in line with K Halliday's suggestions, made at a site visit, except that, contrary to his advice, the cross would be positioned quite close to the north wall. That was impractical, as the cross was carved on all four sides and all four needed to be clearly visible. The cross needed to be brought out from the wall so that it could be viewed in the round. The Archaeology Adviser agreed, and also agreed that an archaeologist should be present when the cross pieces were moved and should examine any previously unseen surfaces, and a record should be made of the below ground surface revealed by the removal of the pews and relocation of the font. It was pointed out that there was quite a bit of the cross missing between its top and bottom sections, so perhaps someone (for example, Nigel Copsey) could prepare a piece of stone to fill that gap to illustrate its original size. There was no specific provision for interpretation in this scheme, but there was a good deal of information readily available in the church. The CBC would have to be consulted, as would HE.

This was linked to the Abbey's Origins Project funded by an NLHF grant and formed part of the Activity Plan. The medieval monastic gardens, originally to the south of the Abbey, would have been a place of tranquillity, and would have addressed food insecurities and met medicinal needs. These issues were still pressing today, with food poverty particularly rife in Selby. The garden would connect this medieval monastic way of life to the modern-day providing access to green space, seating, a community herb garden and activities to improve wellbeing in the local community. Raised beds would be planted including accessible beds for wheelchair users, increasing the plant life in the churchyard and creating a community herb garden to draw on for food. This would connect to Selby's Community Fridge and food waste projects. Flora will be planted to stimulate local bio-diversity and connect directly to the three systems of monastic planting, 1. Food 2. Medicine 3. Tranquillity.
