



The Secretary advised the meeting that the CBC had updated its guidance on statements of significance and needs following a year-and-a-half review process with stakeholders. As part of the new guidance, new templates for statements of significance and needs had been provided and should be used for ongoing faculty applications. These would be available when the Building Management Portal was released later this year, and the current Online Faculty System would turn off access to the old format.
